**Important note:** Please do not make any individual travel arrangements to and from Venice before receiving confirmation of your booking (which will be sent in February 2020).

**Travel documents:** EU-citizens require a machine-readable passport which must be valid for a minimum of six months after the return date. Citizens of other nations are responsible for inquiring about individual entry requirements and organizing necessary visa's, where applicable, prior to travel.

**Tour operator:** Verkehrsbüro-Ruefa Reisen GmbH, Lassallestrasse 3, 1020 Vienna, Austria, is entered in the register of businesses entitled to exercise travel services at <https://www.gisa.gu.at/abfrage> under GISA number 23543010. The entity warranting for us is Commerzbank AG, Vienna branch, Hietzinger Kai 101-105, 1130 Vienna, by virtue of warranty statement no. 3111901662. Europäische Reiseversicherung AG, Kratochwilstraße 4, 1220 Vienna - emergency hotline +43 1 317 25 00, fax +43 1 319 93 67 - acts as the liquidator. To these entities, all claims shall be staked out within 8 weeks starting from the occurrence of the events stipulated in Sect 1 Para 3 of the Austrian Travel Agency Regulation failing which any claim will be forfeited. In the event of booking (yet, at the earliest, 11 months before the end of travel) a down payment in the amount of 20% of the cost of travel shall be paid. The final payment shall be due for payment, at the earliest, 20 days prior to commencement of travel immediately against and in turn for delivery of the travel documents. The CTC of Verkehrsbüro-Ruefa Reisen GmbH (see [www.ruefa.at/veranstalter](http://www.ruefa.at/veranstalter)) shall be applicable.

Prices updated on a daily basis, as of Oct 2019, prices subject to change.
